3. APPLICATION FOR INSPECTION 2012/2013

Please note that the closing date for application for inspection for 2012/2013 is the end of September 2012. If any application reaches the office from 1 October 2012 you as member will forfeit your free inspection for the year and will be invoiced the quantity of kilometres travelled.

4. 2013 AUCTION DATES

Please note the date's needs to reach the office not later than 30 October 2012. Thorough planning needs to be done to prevent an auction 7 days apart in the same area. If your application does not reach the office by the end of October 2012 you will forfeit your date and it will be made available to another breeder.

5. AGM 20 JULY 2012

FEEDBACK

Congratulations to our two new Council members, Dr. Johan Henning and Mr. Johannes van Rensburg. Good luck with the new challenges.

Performance testing: Not compulsory, but highly recommended.

DNA of C & SP bulls: All breeding bulls used in your herd must be DNA profiled by the end of 31 January 2013.

Birth and registration certificates: Unanimous decision that no more certificates will be issued. Studbook will adjust their fees.

Logix access: All breeders do have access. You can register at www.logix.org.za

Embryo flushing: Flushing of heifers may continue, she just needs to produce her own calf by 42 months and not exceed the 730 inter-calving days. A grace period of 2 months is granted per flushing for maximum of 3 flushings. The grace period is effective from 1 July 2012.

The date for the implementation of the proposed production norms is 1 July 2012. The grace period for the phasing in of production norms for animals that have been flushed for embryos before 1 July 2012, is 730 days from 1 July 2012.

Constitution and bye-laws: All changes unanimous accepted. New constitution available on the website: www.borgan.org.za

Progeny on auction catalogues: All progeny (own produced and embryo calves) will be noted on the catalogues.

HDM of embryo calves being shared: The marking remains as it is. We will inform you if any changes.

6. LATE BIRTH NOTIFICATIONS

Please note the new fees for late birth notifications as from 1 September 2012:
90 – 180 days: R250.00 per animal.
180 days and more: R500.00 per animal.
Keep in mind that the birth notifications of 180 days and older need be approved by the Board. Birth notification needs to reach the office or Studbook within 3 months (90 days).
Any notification after 90 days will be charged as mentioned above.

7. IMPORTATION OF EMBRYOS

Council discussed the alleged unconstitutional importation of embryos from Zimbabwe at its meeting of 6 September 2012. The temporarily suspension of services to Messrs. Adriaan Rall, Riaan Strydom and Mark Hook has been lifted, pending the outcome of the investigation of the SAPS.
