5. EMBRYO CALVES

Note that co-ownership of female animals is currently in process of programming. The system will be tested and once 100 % operational you will be informed immediately. Until further notice, please continue with the registration process as usual.

Please note that all outstanding birth notifications of embryo calves need to be submitted before 31 March 2013. As from 1 April 2013 the birth notifications need to be submitted within the 3 months period. Any birth notification received after 3 months a late birth notification penalty will be charged. Penalties as follows: 91 – 180 days: R250.00 + VAT per animal, 181 days and older: R500.00 + VAT per animal (The breeder need to request the Board per letter the acceptance of the late birth notification).

Any birth notification should reach Studbook within 3 months (90 days).

The penalties are for AI, natural service and Implantation.

6. CALENDAR 2013

Feedback is more than welcome. Holiday dates will be add to the 2014 calendar.

Please note that the advertising in this calendar are for all breeders, it is a Society's Calendar. You will be notified in advance for the bookings for the 2014 calendar.

7. JOURNAL 2013

9. FLUSHING OF HEIFERS

The decision at the AGM was that heifers could be flushed but the responsibility lies with the owner to ensure the heifer calves naturally before 42 months. They may not exceed the 730 day inter calving period. A grace period of two months per flushing for a maximum of three flushings is allowed. This grace period is effect from 1 July 2012.

10. FLUSHING ANIMALS

Friendly reminder: Cows of which embryos has been flushed must produce her own natural calve before 30 June 2014 or else she will be deregistered. It is therefore essential that the embryos of the cows at risk be implanted immediately into recipients. These recipients must calve before the cut off date of 30 June 2014 or else you will lose the embryo and the progeny.

11. CERTIFICATES

Friendly reminder: Unanimous decision at the AGM that no more certificates will be issued. You are more than welcome to request in writing to receive certificates. Studbook will invoice from 1 July 2013 per certificate.
