1. Die BORAN Genootskap bestaan uit lede met gemeenskaplike belange wat onderling afhanklik is van mekaar en wat verantwoordelikhede deel vir die welvaart van die ras, die Genootskap en al sy lede, derhalwe is enige handeling wat die Genootskap, ras of lede tot nadeel strek, onetiese optrede.

The BORAN Society consists of members with common interest who are mutually dependent on each other and who share responsibilities for the welfare of the breed, the Society and all its members, therefore an action that harms the Society, breed or members, is an unethical action.

2. As lid van die BORAN Genootskap van Suid Afrika verbind ek myself tot die volgende etiese optrede:

As a member of the BORAN Society of South Africa, I commit myself to the following ethical conduct:

- 2.1 My optrede sal die letter en gees van die grondwet, verordeninge, reëls en ander vereistes van die Genootskap wat van krag is, weerspieël.

My actions will reflect the letter and spirit of the constitution, bye-laws, rules and other requirements of the Society in force.

- 2.2 Ek sal nie toelaat dat persoonlike belange in konflik met die algemene belange van die BORAN Genootskap gestel word nie.

I will not allow personal interests to conflict with the general interests of the BORAN Society.

- 2.3 Ek verbind myself tot die positiewe beeldbou van die ras, Genootskap, sy ampsdraers en lede en sal nie lasterlike of skadelike uitlatings maak teen die ras, Genootskap, sy ampsdraers en lede nie.

I commit myself to the positive image building of the breed, Society, its office bearers and members and will not make defamatory or harmful statements against the breed, Society its office bearers and members.

- 2.4 Ek sal altyd betroubare inligting verskaf aangaande ouerskap, prestasie, gesondheid en vrugbaarheid van diere.

I will always provide reliable information regarding parentage, performance, health and fertility of animals.

- 2.5 Myself sal beywer vir die bevordering en vooruitgaan van die BORAN-ras, die Genootskap, BORAN klubs en lede.

Myself will strive for the advancement and progress of the BORAN breed, the Society, BORAN clubs and members.

- 2.6 Ek inligting wat die ras tot voordeel strek, sowel as inligting wat tot nadeel van die ras mag wees, bekend sal maak aan die Genootskap en sy ampsdraers.

I will disclose information that benefits the breed, as well as information that may be detrimental to the breed, to the Society and its office bearers.

- 2.7 Myself distansieer van praktyke wat reeds as nadelig en nie bevorderlik vir die ras beskou word.

Distancing myself from practices that are already considered harmful and not conducive to the breed.

2.8 My handeling en optrede van so aard sal wees dat dit nie doelbewustelik medetelers se teelvordering belemmer nie.

My actions and conduct will be of such a nature that it does not deliberately hinder fellow breeders' breeding progress.
